 There was an increase in revenue (21%) in the 2023-2024 season over the 2022-2023 season, likely due to more participation in the recreation program, as well as the WAG & XCEL Programs.

- It is not anticipated OGC will experience the same growth for the 2024-2025 season.
- Expenses increased (17%) in the 2023-2024 season over the 2022-2023 season.
- Notable item that a ~\$90,000.00 expense was incurred from credit card transactions.
- A general increase in cash and investments, bringing OGC's assets to over \$1M.
- Accounts receivable increased from ~\$50,000.00 to ~\$100,000.00.
- ~\$73,000.00 of deferred income (1/3 of which is in credits to OGC Families).
- Net assets General Fund \$430,000.00 Currently 1.8 months of operations.
